Interim Action Statement of Basis/Proposed Plan F-Area Tank Farm, Waste Tanks 17 and 20 at the Savannah River Site Available for Public Comment

The United States Department of Energy (DOE) will release an Interim Action Statement of Basis / Proposed Plan (IASB/PP) for the F-Area Tank Farm (FTF) Waste Tanks 17 and 20 on August 14, 2012 describing the preferred interim remedial approach for the stabilized waste tanks. The South Carolina Department of Health and Environmental Control (SCDHEC) will also release a draft Resource Conservation and Recovery Act (RCRA) permit modification for the proposed interim remedial action for these tanks. These documents will be available for public review and copying at the locations listed below. The forty-five (45) day public comment period is scheduled for August 14, 2012 to September 28, 2012.

The IASB/PP was completed to facilitate the terms of the Federal Facility Agreement (FFA) for Savannah River Site (SRS) governing the investigation and cleanup of waste units. The FFA integrates the requirements of RCRA and the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA). DOE has worked with the United States Environmental Protection Agency-Region 4 (EPA) and the SCDHEC to ensure the interim remedial approach is consistent with all applicable environmental requirements. The objective of the interim remedial action is to prevent premature degradation of the engineered barriers associated with stabilization of the waste tanks. DOE, EPA, and SCDHEC have reviewed the risks associated with the stabilized waste tanks and have evaluated alternatives. Annual Visible Engineered Barriers Inspections is the preferred alternative for the stabilized FTF waste tanks.

The FTF is a 22-acre site within the General Separations Area consisting of 22 liquid waste storage tanks and various ancillary structures and transfer lines. There are three major waste tank types in FTF that range in size from 750,000 gallons (Type I tanks) to 1.3 million gallons (Type III/IIIA and Type IV tanks) that have varying degrees of secondary containment and intra-tank interference, such as cooling coils and columns. FTF was constructed to receive waste generated by various SRS production, processing, and laboratory facilities. The use of FTF isolated these wastes from the environment, SRS workers, and the public. Waste Tanks 17 and 20 are Type IV tanks constructed in the late 1950s. These waste tanks have a single carbon steel liner with a spherical reinforced concrete domed roof. Waste Tanks 17 and 20 were operationally closed and removed from service in 1997 in accordance with an approved General Closure Plan and tank-specific Closure Modules. The tanks were isolated from the remaining operating facility and filled with grout.

Comments on the IASB/PP and the draft RCRA permit are requested by September 28, 2012. Upon completion of the public comment period, a Responsiveness Summary that addresses public comments will be prepared. The Responsiveness Summary will be made available with the Interim Record of Decision and the final RCRA permit modification and will be sent to each person who submits comments.
