

Badging Requirements

To be badged for entry to Savannah River Site, individuals must present ONE of the following identification documents:

- U. S. Passport or U. S. Passport Card
- REAL ID – compliant Driver’s License or Identification Card.
- Enhanced Driver’s License.
- HSPD-12 PIV Card.
- Department of Defense (DoD) Common Access Card (CAC) – Except CACs with blue bar.
*FBI credentials are accepted with one of the IDs listed above or a Driver’s License listed below in the primary documents list.

OR a combination of one selection from Primary Docs and one selection from Secondary Docs below:

***Please note, for HSPD-12 enrollment two forms are required and must be a combination of one primary and one secondary document listed below.**

- Photo required for all forms of primary identification.
- All documents must bear the same name.
- All documents must be originals or certified copies; photocopies will not be accepted.
- All documents must be unaltered.
- All documents must be unexpired.
